

In 1992 the William E. Sadowski Trust Fund was established to ensure affordable housing in one of the country's thriving real estate markets, the State of Florida. By linking a documentary stamp tax to all real estate transfers (20-cent-per-\$100), a mathematical equation for economic justice was set into play. As home values rise and more land is sold for development, the amount of money available for affordable housing programs rises, too. The idea was to extend home ownership—one of the most stabilizing features of American life--and affordable rental housing to more Floridians whose low wages might squeeze them out of the housing market. Given that the average cost of an existing home in Florida has dramatically outpaced the average household income since then, the Trust Fund benefits both low- and middle-income workers-as it has done for thousands of Floridians in its fourteen-year history.

After ten years of Trust Fund revenue-collection and disbursements for affordable housing, Governor Bush began to envision other uses for the Trust Fund's impressive returns. With the FY03-04 state budget, he



proposed its elimination, with the justification that, "Trust funds tie legislators' hands with spending mandates from years past." But the Legislature didn't go for that, reauthorizing the housing trust funds in 2004. They did, however, sweep over \$347 million in collected but yet-unauthorized housing funds into the state's General Revenue to be spent on other line items of their choosing.

In 2004 the Governor again sought to eliminate the Trust Fund—this time proposing a phase-out—despite a windfall of \$3 billion in additional (i.e., non-Housing Trust Fund) revenue projected for the next fiscal year. And again the Legislature didn't go for it. So in last year's Session (2005), rather than seeking the elimination of the Trust Fund, the Governor returned

with a proposal for a permanent cap of \$193 million—harvesting all revenues beyond that for other priorities. And it was this proposal that the Florida Legislature finally approved. They voted for a cap of \$243 million—representing less than half of the money that would otherwise go to affordable housing. Unless the cap is repealed in the 2006 legislative session, it is scheduled to take effect on July 1, 2007.

Despite the Governor's concern that, "...we cannot tax our way to prosperity," he has never proposed a reduction of the real estate documentary stamp tax for affordable housing to avoid what he has termed "excess revenues." In fact, the Governor's proposed State Budget (FY2006-07) includes \$5.8 billion in new money that wasn't in last year's spending plan (a record one-year increase); is 46 percent higher than the first budget he approved in 1999; and is largely underwritten with what he expects to skim off the affordable housing trust fund. To that he has added Sadowski funds collected but as yet unauthorized for spending from last year, leaving an oddly large amount in the Fund in a year of hurricane survivors and evacuees with increased housing needs.

Just how much your own county stands to lose in housing funds is detailed within this publication. Use this information with your legislator to demonstrate just what's at stake for your community. Florida Impact will be working with the Florida Housing Coalition on this effort to "scrap the cap," recognizing that affordable housing is an integral part of neighborhood revitalization and facilitates a safer environment in which all children can grow.

Programs funded by the Sadowski Affordable Housing Act

- **SHIP (State Housing Initiatives Partnership):** Approximately 70% of the money from the trust funds is given to this program. SHIP provides direct funds to local governments in 67 counties and 48 additional cities to increase affordable housing opportunities in their communities. Each local government receiving SHIP monies must adopt a plan that is consistent with SHIP's goals and parameters.
- **Catalyst Training Program:** Presents training and technical assistance to local governments and nonprofits using SHIP funds.
- **SAIL (State Apartment Incentive Loan Program):** Stimulates production of affordable, multi- and single-family rental housing for very low-income individuals and families in Florida. SAIL is a development incentive program, which leverages state loan funds, local government contributions, developer equity, and private bond financing.
- **HAP (Florida Homeownership Assistance Program):** Helps low-income individuals and families purchase their own homes by providing no interest, second mortgage loans.
- **PLP (Predevelopment Loan Program):** This program provides financial assistance for predevelopment costs, site acquisition, and development of land for housing affordable to individuals or families with very low and low incomes.
- **HOME (Home Investment Partnership Program):** Offers second mortgage, low-interest loans to eligible housing providers to develop affordable housing units from federal funds. This program is federally funded.
- **Florida Affordable Housing Guarantee Program:** Provides guarantees on taxable loans and tax-exempt loans in order to encourage private sector lending for affordable housing.
- **Homeless Emergency Shelter Grants:** Funded by HUD, these grants are awarded to state governments, large cities, urban counties, and/or U.S. territories to be given to homeless shelter facilities. The purpose is to provide "homeless persons with basic shelter and essential supportive services."
- **Homeless Housing Assistance Grants:** Helps to fund the construction or repair of permanent or transitional housing for homeless persons.
- **Low Income Emergency Home Repair:** Assists low-income people, especially the elderly and physically disabled, with emergency house repairs putting them at risk.

CALLS FOR A RETURN TO FULL FUNDING

FOR HOUSING IN FY06-07

1. The Florida Legislature proclaimed in statute that by 2010 all Floridians would have decent and affordable housing. To that end, the Florida Legislature enacted a dedicated revenue source for affordable housing, known as the William E. Sadowski Affordable Housing Act.
2. Sadowski Act monies are statutorily dedicated by formula to the state and local housing trust funds with 70% of the revenue dedicated to local governments through the SHIP program (a grant to local governments) and 30% of the revenue dedicated to the state to fund successful legislatively created programs such as SAIL.
3. The Florida Legislature has closely scrutinized both the state and local housing trust funds and Florida's housing programs. These reviews have shown that Sadowski Act monies have been an unequivocal success in:
 - Building quality single family home ownership;
 - Building quality multi-family rental with resident amenities and programs,
 - Leveraging public dollars with private investment at a ratio of over 7:1; and,
 - Providing an economic boost to Florida far in excess of the amount of funds appropriated for housing (due to the leveraging and the multiplier effect).
4. The Governor has recommended that \$302 million be spent in FY06-07 for hurricane housing recovery programs. We commend the Governor for this request.
5. However, the Governor has recommended that only \$243 million be spent on ongoing successful and needed housing programs such as SHIP and SAIL. While this recommendation is an increase compared to FY05-06, it is actually a 2.6% decrease from the \$249.4 million funding level of FY02-03.
6. Florida used the housing trust fund monies exclusively for housing from 1992 through 2003, fully funding housing each year. The last year of full funding was FY02-03, when housing appropriations were \$249.4 million. Since that time, funding was reduced to \$193 million, with housing trust fund monies either diverted or left unappropriated.
7. In FY06-07, over \$939.5 million will be available for appropriation from the housing trust funds (there is no cap on the housing trust funds in FY06-07). This leaves an additional \$394.5 million available for housing appropriations, even after the Governor's recommendations of \$302 million for hurricanes and \$243 million for ongoing programs.
8. Why spend all of this money on housing? The simple answer is that we need many more state housing dollars just to serve the same number of families that were served in 2002. The reason: since 2002 the cost of a median priced existing home has increased by 77%, while median income has risen by only 1.4% —thus each family needs significantly greater assistance compared to what that family needed four years ago.
9. The result: the workforce is priced out of the housing market. Florida's communities, Florida's families and Florida's economy can no longer afford less than full housing appropriation. Florida is facing its greatest housing crisis ever.
10. Unlike many a crisis, Florida prepared for this one by creating an effective housing funding system. The housing trust funds were designed to have more money available when housing costs escalated. Coupled with our innovative housing programs, we have enough resources to address the housing crisis—but only if the housing money is utilized for housing.


